Corrigendum

All interested bidders who wants to participate in notice inviting bid no. 2743 dated 02.05.2022 are advised to read following changes:-

- 1. In the e-tender form of soybean seed, the following point number 3 in the note in the bid form at page no. 6 should not be considered included in the tender form.
 - Quotation of price :- There are various informations to be provided by the bidder i.e. name of variety, year of notification, category of hybrid, class of seed, stage of seed, quantity offered in the format of technical bid and correspondingly the rate has to be quoted in BOQ only. In BOQ rate per quintal of offered seed FOR anywhere in Rajasthan including all taxes, octroi, transit insurance etc. for each variety as offered in technical bid has to be filled e.g. the rate for variety filled against 'A' shall be filled against 'A' in Financial Bid (BOQ).

The evaluation of such Financial Bid (BOQ) shall be done manually by the procurement committee and the decision shall be binding for all bidders. The comparative statement prepared by e-procurement portal shall not be applicable.

2. In the e-tender form of Soybean certified seed, the work experience must be read 20% instead of 50%. The terms and conditions related to this are as follows-

Bid form condition no. 12 (Page no-5)

12. Past performance as prime supplier of seeds during any one year of last five years / current year (Attach copies of satisfactory completion certificate issued by any Govt. / public sector organization). Such certificate relating to current year may also be considered. This past performance should have minimum value of 20% of the estimated cost of seed supply in a year. In case a bidder participate in more than one item then the required past performance shall be sum of the required past performance of all such item individually. If any bidder fails to qualify this criteria, all of the bids submitted by that bidder shall disqualify.

Section - A General Instruction to Bidders (Page no.-10)

14. Past performance:- The bidder must be a prime supplier of seeds of a similar nature during the last five years. Attach copies of purchase orders issued by any Govt. / public sector organization along with certificate of satisfactory completion relating to minimum one year in the last five years. Such certificate relating to current year may also be considered. This past performance should have minimum value of 20% of the estimated cost of seed supply in a year. In case a bidder participate in more than one item then the required past performance shall be sum of the required past performance of all such item individually. If any bidder fails to qualify this criteria, all of the bids submitted by that bidder shall disqualify.
